Hello IWF Idaho Members,

Can we talk? I chair the IWF-Idaho Program Committee and I have the opportunity each month to spend an hour or more with some amazing women.

We are committed to bringing the forum programs of interest. For the past eight month since Covid 19, we have had to operate in a different way. Many of the things that we did in the past have been reduced to virtual presentations. Looking ahead, our plan is to operate virtually until it is safe to have face to face gatherings. Join Our New IWF Idaho Book Club



Member Spotlight

IWF Idaho Outgoing Treasurer, Carolyn Lister



Carolyn grew up in L.A. and moved to Ketchum in the 1980's. Carolyn taught herself computer coding and developed the ambulance billing program for the City of Ketchum, became a firefighter and an advanced EMT when women were not welcome in these services, and obtained a 501(c)(3) status for the Ketchum Sun Valley Volunteer Firefighter Association. Carolyn served on the board of this charity and donated bookkeeping services. Carolyn began working for a private client handling large assets worldwide, and was eventually promoted into an accounting position. The non-profits ERC and The Sawtooth Botanical Garden grew out of that organization while Carolyn was on staff. In the mid 90's, Carolyn became the Chief

Financial Officer. In 2006, Carolyn created her current company, Sage Bookkeeping Inc. to provide the community with a consistent and standardized bookkeeping service. Carolyn has grown this company from 1 employee and a handful of clients to 10 employees and over 200 clients across the nation, and is currently the largest service in Idaho. Carolyn teaches bookkeeping classes and provides continuing education and consulting for other bookkeepers. Carolyn is on the board of Rotary Hailey and the IWF Idaho, to whom she donates bookkeeping services.

Sarah Michael Honored as Winter Wildlands Alliance Founder



Sarah recently shared an <u>article published by Winter Wildlands Alliance</u>, a Boise-based national non-profit representing nordic and backcountry skiers, which she founded in November 2000. Book Recommendations

Staying Connected through Literature

Alongside efforts to keep our IWF Idaho community together via Virtual Events, Vice President Peggy Goldwyn had the wonderful idea of sharing book reviews and recommendations in our monthly newsletters. A Review of White Fragility: Why It's So Hard for White People to Talk About Racism by Robin DiAngelo submitted by Jane Conard

After the tragic killings of Breonna Taylor and George Floyd last May (not to mention other lamentable incidents of civil rights violations before and since), many of us have been motivated to become better educated and more understanding of the racial discrimination and tensions that are so enduring in our country. While there is a plethora of good fiction and nonfiction books on the subject, I want to focus on one book that has been on the New York Time bestseller list since it was published in 2016, with mixed reviews. It has become controversial; people either love it or hate it. After a note about the author, a brief synopsis of the content, and a sample of reviews about the book, I'll share my opinion.

Robin DiAngelo's *White Fragility*, published in 2018, met with generally positive reviews and a place on the New York Times bestseller list. DiAngelo's short book, 192 pages, draws heavily from her experience as a diversity training consultant for large corporations. After five years in that occupation, she began work on her doctorate in multicultural education at the University of Washington. She coined the term "white fragility" in 2011 to describe the defensive behavior of whites she had observed when they were challenged about their assumptions about race in her diversity training sessions. Her book titled after her invented term includes an academic overlay of sociological analysis of whites' attitudes about racism, "identity politics," and assumptions about the moral superiority of whites reflected in American history. DiAngelo claims the anger, fear, and guilt elicited when whites are confronted by the racist aspects of our culture belie the underlying desire to maintain white dominance. Her analysis of white reactions finds a pervasive sense of superiority and entitlement. She offers anecdotal evidence from her

years of diversity training to support her thesis. She continues her reasoning to assert that merely being non-racist is not good enough because then you are a bystander who does nothing in face of active harm to a Black victim. Any protestation to the contrary, she argues, demonstrates inherent racism. If you are a passive observer, you are complicit; you are a racist. Whites must actively do "the work" to identity and change their inherent racism in order to become a non-racist.

The 2018 reviews of *White Fragility* focused primarily on the explanation of racism. The Los Angeles Review of Books praised the author's perception and commitment to revealing racism, but saw her work as a description of the status quo, not as a guide to correcting it. Similarly, the Publisher's Weekly praised the book as being a comprehensive book challenging racism, but faulted it for offering no concrete solutions. The New Yorker magazine, while acknowledging the book as an "irrefutable exposure of racism," viewed it as diagnostic, not solution oriented.

In 2020 with the growing strength of the Black Lives Matter movement, *White Fragility* again topped the New York Times bestseller list. But this time there was a surge of negative reviews. The Guardian described the book as "psychobabble" that shifts the focus from necessary structural change to individual bias, leaving the real issues untouched. The Atlantic (see its online Issues publication, July 15, 2020) headlined a harsh review by John McWhorter, linguistics professor at Columbia University, under the title "The Dehumanizing Condescension of *White Fragility*." McWhorter labeled the book as a "racist tract" that is condescending to Blacks to the point of infantilizing and dehumanizing them.

My assessment is closer to the Guardian review. DiAngelo's confrontational and pseudo academic style is off-putting and negative. Instead of persuasion to urge the reader to examine and change racial biases, she proves and enhances her theory of white fragility, which indeed may have been her objective. Instead of labeling whites as racist because they are unaware or unsuspecting victims of their implicit bias, it would have been more productive to inspire whites to change their views through a plan of specific actions. Although it is said that people can't change their attitudes, they can change their actions. Perhaps with changes in actions we can halt the generational creep of implicit bias throughout American society and begin a path toward the end of systemic racism.
